Detailed guidelines:

- All valid members of the Society-medical or lay – shall be eligible to be elected as office bearers of the association.
- Any member satisfying the eligibility criteria can stand for an election as an office bearer or Governing Council Member and shall be proposed by any valid member (of at least 3 years standing) and seconded by another valid member (of at least 3 years standing) of the Indian Epilepsy Association.
- The electorate of the President Elect, Secretary General and Treasurer shall be on an all India basis while that of other Governing Council members shall be the respective States.

The Election shall be for the following posts:

- President-Elect will automatically be the President in the following term.
- For the post of President Elect, the candidate should have served at least one Term in GC as an elected Member (Not as Ex Officio Member)
- President elect and President for one term only. All other posts eligible for reelection for one more term only
- A member cannot contest for more than one post simultaneously .If a member does not complete the term of office (unless for valid reasons), he will not be eligible to contest for any post in future.
- Elections shall be by postal ballot. Canvassing in any form for any election shall disqualify the candidate.
